Report on Race Meeting held at Gawler Racecourse  
by the Gawler and Barossa Jockey Club on Saturday, 19 December 2020

**RACE 1: TAB / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 Metres**

**BACK TO FRONT** (T. Pannell) - near the 200 metres was inconvenienced as BETTA EDDIE rolled in. A post-race veterinary examination revealed no visible abnormalities.

**BETTA EDDIE** (J. Maund) - jumped away awkwardly. Near the 800 metres was obliged to be steadied and lost its position when tightened onto SCOTCH ON THE ROCK as THRILL KILL was obliged to be eased and shifted out. Raced keenly in the middle stages of the event. Near the 200 metres rolled in onto BACK TO FRONT, which was inconvenienced.

**OUTLAWS REVENGE** (D. Tourneur) - in the vicinity of the 800 metres shifted in when insufficiently clear of THRILL KILL, which was obliged to be eased and shifted out onto BETTA EDDIE, which was obliged to be steadied and lost its position when tightened onto SCOTCH ON THE ROCK. Rider was found guilty of a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 30 December 2020 and to conclude at midnight on Wednesday, 6 January 2021: a period of four meetings.

**THRILL KILL** (C. Jones) - in the vicinity of the 800 metres was obliged to be eased as OUTLAWS REVENGE shifted in when insufficiently clear and as a result, shifted out onto BETTA EDDIE, which was obliged to be steadied and lost its position when tightened onto SCOTCH ON THE ROCK.

**DAILY SPIRIT** (J. Eaton) - hung in under pressure in the straight and proved difficult for the rider to ride her mount out to the finish. A post-race veterinary examination revealed no visible abnormalities.

**INDIAN GAZELLE** (B. Vorster) - slow to begin.

**RACE 2: SOUTH AUSTRALIAN BOOKMAKERS LEAGUE BENCHMARK 64 HANDICAP**  
**- 1705 Metres**

**TIGNANELLO (NZ)** (B. Vorster) - prior to the running of Race 1, stable representative Mr F. McCarthy advised Stewards of a change in tactics that being they would instruct the rider to be more patient and to allow the gelding to see out the distance in today's event. Settled mid to back. In the vicinity of the 500 metres was tightened onto BAJAN and lost its position as GOING GAGA, which was hanging out, shifted out. A post-race veterinary examination revealed no visible abnormalities.

**BAJAN** (T. Pannell) - in the vicinity of the 200 metres bumped with AUSSIE SOJOURN which was inclined to lay out. In the vicinity of the 100 metres bumped with AUSSIE SOJOURN which was inclined to lay out and shifted out and away from MR EPIC.

**GOING GAGA** (J. Eaton) - in the vicinity of the 500 metres hung out and shifted out onto TIGNANELLO (NZ), which was obliged to be steadied and lost its position when tightened onto BAJAN. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground in future. Inclined to hang out for the remainder of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr M. Kluske, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**AUSSIE SOJOURN** (D. Tourneur) - inclined to lay out under pressure in the straight and in the vicinity of the 200 metres bumped with BAJAN. In the vicinity of the 100 metres shifted out and away from MR EPIC and bumped BAJAN.

**FLYING PIERRO** (J. Toeroek) - shortly after the start shifted in, in an attempt to gain cover.

**RACE 3: HOLDFAST INSURANCE BENCHMARK 68 HANDICAP - 1200 Metres**

**TAKEN OFF** (K. Crowther) - held up for clear running from rounding the home turn until in the vicinity of the 100 metres and shifted out to obtain clear running and in doing so, inconvenienced MYSTICANO.

**MYSTICANO** (J. Toeroek) - in the vicinity 200 metres was tightened for room between MAID IN MILAN and TONY'S REWARD which rolled in. In the vicinity of the 100 metres was inconvenienced as TAKEN OFF shifted out to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

**TONY'S REWARD** (C. Jones) - in the vicinity of the 200 metres rolled in onto MYSTICANO.

**LOVE MAGIC** (J. Eaton) - knuckled on jumping away. Held up for clear running from rounding the home turn until in the vicinity of the 200 metres when racing between TULLYS GOLD and SOCIAL MEDIA.

**SOCIAL MEDIA** (M. Collett) - over-raced in the early stages and got its head up on a number of occasions when being restrained.

**AMBERTONE** (C. Lions) - contacted a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination and passed fit to race.

**RACE 4: BRONWEN DARRALL MEMORIAL CLASS ONE HANDICAP - 1200 Metres**

**HARPUNA** (J. Toeroek) - hung out from rounding the home turn and at the entrance to the straight bumped POSSUM BORN. Inside the 200 metres bumped with POSSUM BORN on a number of occasions.

#### **RACE 4: BRONWEN DARRALL MEMORIAL CLASS ONE HANDICAP - 1200 Metres (Cont'd)**

**POSSUM BORN** (B. Vorster) - raced keenly in the early and middle stages of the event. At the entrance to the straight bumped with HARPUNA, which was inclined to hang out and shortly after became tight to the inside of YOU ES MARSHAL, which rolled in marginally. Inside the 200 metres rolled in and away from YOU ES MARSHAL and bumped with HARPUNA on a number of occasions.

**BUBBLES MCGINTY** (J. Eaton) - jumped away awkwardly, shifted out and shortly after shifted in to obtain cover.

**DIHHI** (S. Metcalfe) - a post-race veterinary examination revealed no visible abnormalities.

**LUCY DIAMONDS** (S. So) - had difficulty obtaining clear running from the entrance to the straight until in the vicinity of the 200 metres.

**ZOUSTORM** (D. Tourneur) - had difficulty obtaining clear running for a short distance in the vicinity of the 200 metres.

**MISS HEDY** (M. Collett) - shortly after the start shifted in to obtain cover.

#### **RACE 5: GJ CIVIL BENCHMARK 58 HANDICAP - 1100 Metres**

**ROCK HARD** (S. Metcalfe) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

**OLIVE GROVE** (C. Jones) - jumped away awkwardly. In the vicinity of the 200 metres rolled out and bumped DYNASTIC.

**DYNASTIC** (K. Zechner) - in the vicinity of the 200 metres was taken out by and bumped with OLIVE GROVE which rolled out, and bumped with ULTIMATE VICTORY.

**ULTIMATE VICTORY** (D. Tourneur) - in the vicinity of the 200 metres bumped with DYNASTIC, which was taken out by OLIVE GROVE.

#### **RACE 6: DAVE BINYON MEMORIAL / SABOIS+ BENCHMARK 68 HANDICAP - 2105 Metres**

**CLASSIC WEIWEI** (T. Pannell) - prior to the running of Race 1, stable representative Mr F. McCarthy advised Stewards of a change in tactics that being they would instruct the rider to attempt to be more patient during the event and to allow the gelding to finish the race off. Settled mid to back.

**ALLUSION** (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

**THE RED SEA** (S. So) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by the rider and noted that she used her whip on five occasion over the last 100 metres.

**SIR HUSSON** (D. Tourneur) - commenced to give ground from approaching the 400 metres.

**LAMMA HILTON** (C. Lions) - shortly after the start was restrained and shifted in to obtain cover.

**SOSTENIDO (NZ)** (A. Jordsjo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$500. In determining penalty, Stewards had regard for the totality of the use of the whip by the rider and noted that she used her whip on thirteen occasion over the last 100 metres.

**RACE 7: CORNERSTONE STUD SIR PRANCEALOT SERIES FINAL - FILLIES & MARES  
BENCHMARK 64 - 1200 Metres**

**OUR BENEVENTO** (T. Pannell) - jumped away awkwardly, shifted out and shortly after was unable to improve its position when tightened between PANZER PRINCESS and MAGIC DEE. A post-race veterinary examination revealed no visible abnormalities.

**GALCRUM** (D. Caboche) - in the vicinity of the 300 metres shifted out and hampered MAGIC DEE, which was tightened onto PANZER PRINCESS. Rider was severely reprimanded under AR131(a) and advised to take greater care when his mounts commence to shift ground in future. In the vicinity of the 150 metres rolled out and as a result MAGIC DEE was obliged to alter course. Rider was reprimanded under AR131(a) and advised to take greater care in future.

**THE PUBLIKIN** (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

**JACJAC JACQUI** (P. Gatt) - acting on confirmed advice from Trainer Mr G. Lesnikowski that the mare proved difficult to load onto the float, had lost its composure and would be unfit to race. Stewards declared JACJAC JACQUI a late scratching at 1.34pm.

**RUSTYDUSTYSUNSHINE** (S. So) - a post-race veterinary examination revealed no visible abnormalities.

**MAGIC DEE** (K. Crowther) - in the vicinity of the 300 metres was hampered when tightened onto PANZER PRINCESS as GALCRUM shifted out. In the vicinity of the 150 metres was obliged to alter course to the inside of GALCRUM, which rolled out.

**TINNY BAR BLUE** (B. Vorster) - approaching the 100 metres shifted in, in an attempt to obtain clear running.

**PANZER PRINCESS** (M. Collett) - rider reported the mare did not feel comfortable in its action during the event. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr B. Mueller, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

**RACE 8: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 58 HANDICAP - 1500 Metres**

**MOUNT MADEIRA (NZ)** (M. Collett) - approaching the 1400 metres was obliged to be steadied as FREE HAND shifted in. Got its head up on a number of occasions when racing keenly in the middle stages of the event. In the vicinity of the 100 metres was taken in slightly by FREE HAND which rolled in marginally.

**IGITUR** (C. Lions) - approaching the finish, raced in restricted room to the inside of SYLVAN CREST and was obliged to be steadied.

**FREE HAND** (S. Price) - jumped away awkwardly. Approaching the 1400 metres shifted in onto MOUNT MADEIRA (NZ). Rider was reminded of his obligations under AR131(a) in relation to shifting ground in future. In the vicinity of the 100 metres rolled in marginally onto MOUNT MADEIRA (NZ).

**SYLVAN CREST** (K. Crowther) - inclined to lay out under pressure in the straight. A postrace veterinary examination revealed no visible abnormalities.

**NAKHEEL** (T. Pannell) - in the vicinity of the 100 metres rolled out onto DESERT DUEL, which was obliged to be eased. Rider explained in relation to the mare's poor performance that it travelled well during the event however, when asked to improve from the 500 metres, failed to quicken as he would have liked. He added when tested further from in the vicinity of the 400 metres, failed to respond, was inclined to roll about under pressure in the straight and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8: ADELAIDE PLAINS BLOODSTOCK BENCHMARK 58 HANDICAP - 1500 Metres (Cont'd)**

**DESERT DUEL** (D. Tourneur) - slow to begin. In the vicinity of the 100 metres was obliged to be eased as NAKHEEL rolled out and MOUNT MADEIRA (NZ) was taken in slightly by FREE HAND.

**RACE 9: COOPERS BREWERY BENCHMARK 82 HANDICAP - 1100 Metres**

The start of this event was delayed approximately two minutes.

**BEAUTIFUL FLYER** (E. Boyd) - slow into stride.

**TEQUILA TIME** (T. Pannell) - rider explained in relation to the gelding's poor performance that it never felt comfortable in its action during the event, was off the bridle and failed to respond to his riding throughout the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Co-Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**BIG EFFORT** (S. Price) - hung out from in the vicinity of the 800 metres for the remainder of the event, and as a result the rider could not ride out the gelding in his normal manner. Rider reported due to the gelding hanging out severely, that he had limited control and the saddle slipped back slightly in the vicinity of the 700 metres, placing him at a greater disadvantage. Trainer Mrs S. Hayes was advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

**OAMARU OWL** (C. Jones) - underwent a pre-race veterinary examination on arrival at the barriers who reported the gelding to resent the cross-over noseband. Stewards acting on this advice permitted the cross-over noseband to be removed from OAMARU OWL's gear. Shortly after the start shifted out onto KENYAN WONDER. Rider reported the gelding did not feel comfortable in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**PORT VALE** (O. Ridge) - rider was questioned in relation to the gelding's performance in today's event. He explained PORT VALE began slower than he had expected and therefore he was obliged to settle further back. It was his intention to settle in a forward of mid-field position. He further stated that the gelding raced off the bridle and failed to respond to his encouragement during the early stages of the event and added that the gelding dipped on a number of occasion in the vicinity of the 600 metres. He explained that he tested the gelding at the top of the straight and it only responded to his riding moderately, and over the final 100 metres, he had become concerned with PORT VALE'S action given its racing manners in the earlier stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**KENYAN WONDER** (B. Vorster) - shortly after the start, lost its position when tightened between OAMARU OWL, which shifted out and IRISH MINT.
