

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville
Racecourse by the South Australian Jockey Club on
Saturday, 8 May 2021

Main Track Good 4 (Track with some give in it)
(Downgraded to Soft 5 at 12:58 pm)
(Track with a reasonable amount of give in it.)

Parks Track Good 4 (Track with some give in it)
(Downgraded to Soft 5 at 11:50 am retrospective to Race 1.)

RAIL: Main Track out 2 metres 1200 metres to Winning Post, True Remainder

WEATHER: Overcast / Showery

RIDER CHANGES: Nil

RACE 1: ACCOLADE WINES HANDICAP (MORPHETTVILLE PARKS TRACK) - 1000 Metres

COP A CLIP (J. Allen) - rider explained that the filly did not respond in the manner he expected, was under pressure in the straight, did not finish the event off and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

CHAMPAGNE AFFAIR (S. Metcalfe) - raced very keenly in the early stages of the event.

SEA WITNESS (J. Holder) - near the 900 metres got its head up when being restrained and raced ungenerously for a short distance thereafter.

GAZE GRISE (K. Crowther) - which kicked a perimeter fence in the mounting yard. Was examined by the Veterinary Surgeon on arrival at the barriers and passed fit to start. Rider explained that the tempo in this event did not suit the filly and did not allow it to run on. A post-race veterinary examination revealed no visible abnormalities.

L'IL PIPER (D. Tourneur) - raced keenly in the early and middle stages of the event.

Correct weight for this event was delayed to allow B. Vorster the rider of STAR OF UMA to view the vision in the straight.

Following the running of this event, the track was downgraded to a Soft 5 at 11:50 am retrospective to race 1.



RACE 2: TAB SOUTH AUSTRALIAN SIRES' PRODUCE STAKES (MORPHETTVILLE PARKS TRACK)
- 1400 Metres

THREE KINGS (L. Currie) - was taken out shortly after the start by BLUSHING TYCOON which was taken out and, as a consequence, was hampered when tightened onto COSMIC RANGER. Near the entrance to the straight was brushed by PRINCESS RAFFLES which shifted out to improve. Rider explained the colt travelled well in the early stages of the event, however, when asked for an effort failed to respond and did not finish the event off in the manner expected. A post-race veterinary examination revealed no visible abnormalities.

BLUSHING TYCOON (B. Vorster) - was taken out shortly after the start by FOREVER AND A DAY which shifted out and, as a consequence, shifted out onto THREE KINGS. Approaching the 100 metres shifted in slightly and contacted CLOUDY on several occasions resulting in that horse being taken in slightly inside the 100 metres.

COSMIC RANGER (B. Allen) - was contacted and hampered shortly after the start by THREE KINGS which was taken out by BLUSHING TYCOON.

AEROPORT (S. Logan) - raced wide without cover throughout the event. Laid out rounding the home turn.

CLOUDY (T. Pannell) - from the vicinity of the 400 metres was held up for a number of strides before being able to shift to the outside of FOREVER AND A DAY to obtain clear running. From near the 100 metres was contacted, and taken in, by BLUSHING TYCOON which shifted in slightly, and as a consequence was taken across the running of FOREVER AND A DAY which had to be steadied. Lost its off hind plate during the event.

FOREVER AND A DAY (D. Lane) - shifted out sharply shortly after the start onto BLUSHING TYCOON taking that horse out onto THREE KINGS which in turn was taken out onto COSMIC RANGER resulting in THREE KINGS and COSMIC RANGER being hampered. Near the 50 metres was obliged to be steadied to avoid the heels of CLOUDY which was taken in by BLUSHING TYCOON.

PRINCESS RAFFLES (J. Holder) - shortly after the entrance to the straight when shifting out to improve, brushed with THREE KINGS and thereafter was inclined to lay out for the remainder of the event.

Correct weight for this event was delayed to allow T. Pannell the rider of CLOUDY (third place-getter) to view the vision in the straight. After doing so T. Pannell lodged a protest against BLUSHING TYCOON (B. Vorster) the second place-getter on the grounds of alleged interference from near the 100 metres. After considering the submissions of T. Pannell and B. Vorster and the parties representing the connections of CLOUDY and BLUSHING TYCOON, and after viewing the vision in the straight and acting on their own observations, Stewards dismissed the protest lodged by T. Pannell and declared correct weight.

RACE 3: PETER ELBERG FUNERALS AUTUMN SERIES FINAL (MORPHETTVILLE PARKS TRACK)
- 1400 Metres

BORN TO PLAY (B. Vorster) - Co-trainer Mr. T. McEvoy, advised Stewards prior to the event of a change of tactics, that being that he would instruct his rider to attempt to take up a more forward position in running. Settled outside the leader. A post-race veterinary examination revealed the filly to be lame in the near foreleg.

HE'S A BALTER (T. Pannell) - rider was granted permission to ride this gelding a half a kilogram over its declared weight.

CROWN HARMONIUM (A. Kelly) - had difficulty obtaining clear running from near the entrance to the straight until in the vicinity of the 100 metres.





RACE 4: HAPPY BIRTHDAY MICHAEL LARECKI HANDICAP (MAIN TRACK) - 1200 Metres

The start of this event was delayed approximately two minutes owing to an interstate delay.

OCTANE (A. Kelly) - was awkward to begin. Shifted out and contacted CALYPSO REIGN which was taken out onto SECRET VEGA which was hampered when tightened onto TOO GOOD TOO HARD. Raced very keenly in the early stages of the event.

TOO GOOD TOO HARD (B. Allen) - was held up for clear running from near the entrance to the straight until inside the 300 metres where it was obliged to shift in to obtain clear running, and from that point laid in for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

MALAISE (J. Mott) - shortly after the start became momentarily awkwardly placed on the heels of LEFT HAND MAN. Rider explained that from near the 300 metres when assessing his options to improve he momentarily ceased riding before shifting to the inside of SECRET VEGA to improve his position, and thereafter when making ground over the concluding stages of the event was obliged to race in restricted room when improving into restricted running to the outside of MUSIC ADDITION and inside SECRET VEGA. As a consequence J. Mott was obliged to steady his mount shortly prior to the winning post. A post-race veterinary examination revealed the gelding to be lame in the off foreleg.

DEBT COLLECTOR (D. Lane) - A post-race veterinary examination revealed no visible abnormalities.

SECRET VEGA (T. Pannell) - was contacted by CALYPSO REIGN shortly after the start and hampered when tightened onto TOO GOOD TOO HARD. Approaching the winning post was inconvenienced when obliged to race in restricted room between MALAISE which shifted out to improve and DESIGNER CHEF which raced to its immediate outside.

CALYPSO REIGN (K. Crowther) - was contacted and taken out at the start. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: WESLO SECURITY HANDICAP (MAIN TRACK) - 1050 Metres

ARROW LANE (S. Logan) - lost its off fore plate during the event.

HEAVENLY BRIDGES (S. Metcalfe) - was a late scratching by order of Stewards at 8:57 am acting on confirmed advice from Trainer, Ms K. Mooney, that the mare had exhibited signs of the onset of colic. Trainer was advised that a Veterinary Certificate of Fitness would be required prior to a future trial or race start.

BRAZEN BRANDO (B. Allen) - was awkward to begin.

APPALACHIAN (T. Pannell) - raced keenly in the early stages of the event. Laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

NARRATIVE STAR (B. Vorster) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

LADY PAVLI CHENKO (M. Walker) - raced keenly for a short distance near the 700 metres. From in the vicinity of the 300 metres was held up for clear running until inside the 200 metres where it was obliged to shift to the outside of ARROW LANE to obtain clear running.

RUSHWA (S. Fawke) - was slow into stride and thereafter raced very keenly in the early stages of the event.





RACE 6: FURPHY PROVINCIAL SUPER SERIES FINAL (MAIN TRACK) - 1800 Metres

CALL ME SHAMUS (B. Allen) - shifted in on jumping away and contacted KALAMON. Approaching the 200 metres was obliged to race in restricted room between MONTEFERRANTE and DOES IT DOES IT (NZ) which shifted out.

SADENTE (J. Holder) - raced keenly from near the 1400 metres until near the 700 metres. Was held up for clear running from approaching the 400 metres until approaching the 200 metres where it was obliged to shift in to obtain clear running.

KALAMON (J. Toeroek) - shifted out on jumping away and contacted CALL ME SHAMUS.

APPOLLO JET (T. Pannell) - rider was granted permission to ride this gelding a half a kilogram over its declared weight.

MY GOLDEN CHAIN (A. Jordsjo) - near the 1500 metres shifted in and severely hampered BAJAN which had to be checked when taken in. Rider pleaded guilty to a charge of careless riding under AR131(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period of three race dates (dates to be advised). Broke down near the 300 metres and was restrained by its rider who was subsequently dislodged near the 200 metres. MY GOLDEN CHAIN was humanely euthanased by the Veterinary Surgeon who reported that the gelding had fractured its off hind cannon. A. Jordsjo was examined by the First Care Medical Personnel and declared fit to fulfill her remaining engagement.

BAJAN (C. Lions) - near the 1500 metres was obliged to be checked when severely hampered by MY GOLDEN CHAIN which shifted in. Raced wide without cover throughout the event.

DOES IT (NZ) (M. Walker) - approaching the 200 metres shifted out and inconvenienced CALL ME SHAMUS.

COMFORT GIRL (K. Crowther) - near the 200 metres when racing behind MAVETTE which commenced to give ground, was obliged to shift to that horse's outside in an attempt to obtain clear running and was further obliged to shift to the outside of KALAMON shortly thereafter to improve its position.

RACE 7: TAB SOUTH AUSTRALIAN DERBY (MAIN TRACK) - 2500 Metres

ROYAL MILE (J. Opperman) - raced keenly in the early stages of the event. Near the 1800 metres became awkward on the heels of MONTEPULCIANO.

LIQUEURO (L. Currie) - near the 900 metres shifted out contacting ICHIBANSAN which was hampered when taken wider. Rider was found guilty of a charge of careless riding under AR131(a) for shifting ground when insufficiently clear and was suspended from riding in races to commence midnight Saturday 15 May 2021 and conclude midnight Wednesday 26 May 2021: a period of five meetings. A post-race veterinary examination revealed the gelding to be lame in the near foreleg.

LET'S KARAKA DEEL (NZ) (B. Allen) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty, Stewards had regard for the totality of the use of the whip by B. Allen and noted that he used his whip on two occasions over the last 100 metres.

DEEPSTRIKE (NZ) (D. Lane) - approaching the crossing near the 1800 metres got its head up and raced ungenerously for a short distance. Approaching the 1200 metres became awkward on the heels of runners when being restrained. Got its head up and raced ungenerously for a number of strides.

MILETUS (J. Mott) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

NOBEL HEIGHTS (W. Price) - raced very keenly in the early stages of the event. Approaching the crossing near the 1800 metres became awkward on the heels of DEEPSTRIKE (NZ).

ABREED (J. Holder) - over-raced in the early and middle stages of the event.



RACE 7: TAB SOUTH AUSTRALIAN DERBY (MAIN TRACK) - 2500 Metres (Cont'd)

SOLAR APEX (M. Walker) - approaching the crossing near the 1800 metres became very awkward on the heels of MILETUS for several strides. A post-race veterinary examination revealed no visible abnormalities.

ICHIBANSAN (C. Jones) - near the 900 metres was contacted by LIQUEURO which shifted out.

PERSONAL (D. Oliver) - raced keenly in the early stages of the event. Near the 500 metres was obliged to shift to the inside of MILETUS which gave ground.

RACE 8: ADELAIDE GALVANISING ADELAIDE GUINEAS (MAIN TRACK) - 1600 Metres

CASINO SEVENTEEN (D. Oliver) - was slow to begin.

COOL MAGNUM (B. Vorster) - over-raced in the early stages of the event. Rider reported that his saddle slipped back in running placing him at a disadvantage during the event.

HIGHLY DISCREET (K. Crowther) - was awkward to begin. Shifted out and inconvenienced WAY TO GO PAULA which was taken wider.

AGREEABLE (D. Lane) - was inclined to lay in in the straight. Approaching the 100 metres was inconvenienced by CASINO SEVENTEEN which shifted in slightly and as a consequence shifted in onto POINT BLAZE which was obliged to race in restricted room for a number of strides over the concluding stages of the event.

WAY TO GO PAULA (B. Allen) - was inconvenienced at the start when taken out by HIGHLY DISCREET. A post-race veterinary examination revealed no visible abnormalities.

POINT BLAZE (J. Holder) - was inconvenienced inside the 100 metres and obliged to race in restricted room when tightened by AGREEABLE which shifted in.

SHE'S STYLISH - A post-race veterinary examination revealed no visible abnormalities.

RACE 9: TERRY HOWE PRINTING SA SPRINT SERIES FINAL (MAIN TRACK) - 1100 Metres

TOFF LOVE (B. Vorster) - near the entrance to the straight was held up for clear running and was obliged to shift to the inside of ALL IN WAR to obtain clear running and shortly thereafter near the 300 metres was obliged to be checked when tightened by ALL IN WAR which shifted in abruptly before being corrected.

LANCASTER SOUND (D. Tourneur) - slipped on jumping and shortly thereafter was hampered when tightened onto the heels of ANITRA by ALL IN WAR which was taken in. A post-race veterinary examination revealed no visible abnormalities.

EXTRA MILE (J. Toeroek) - raced keenly in the early stages of the event.


ZARACE (A. Jordsjo) - began awkwardly. Shifted in onto ALL IN WAR which was taken in onto LANCASTER SOUND which was hampered when tightened onto the heels of ANITRA.

ANITRA (B. McDougall) - raced keenly in the early and middle stages of the event.

ALL IN WAR (M. Walker) - near the 300 metres shifted in abruptly and severely hampered TOFF LOVE. Rider was reminded of his obligations when his mounts commences to shift ground.

RIZSKI (J. Holder) - rider was granted permission to ride this gelding a half a kilogram over its declared weight. Was held up for clear running from near the entrance to the straight until near the 200 metres.

TRYGVE (A. Kelly) - approaching the 200 metres was held up for clear running for a number of strides.



TWO ODD SOX (S. Logan) - had difficulty obtaining clear running from near the entrance to the straight and inside the 200 metres was obliged to shift in to obtain clear running, however, was then held up for clear running when racing behind SOUL OBSESSION and ZARACE and was untested to the line.
