INTERIM REPORT

RACE 1: THOMAS FARMS THREE-YEAR-OLD MAIDEN PLATE - 1000 Metres

RISING LEGEND (J. Holder) - rolled in approaching the finish onto CHASING STARS.

WETSHOT (J. Opperman) - proved difficult to load. Trainer Mr J. Opperman was advised a warning had been placed on the colt as a result of it proving difficult to load. Hampered on jumping away when tightened onto UP THE LANE by PRETENTIOUS DIVA.

CHASING STARS (T. Voorham) - hung out throughout the event and approaching the finish, rolled out slightly and became awkwardly placed on the heels of RISING LEGEND, which rolled in slightly.

FLYING BARTY (T. Pannell) - laid out under pressure in the straight.

PRETENTIOUS DIVA (C. Murray) - shifted out on jumping away onto WETSHOT. Laid out under pressure in the straight.

TOTALLY DISCREET (K. Crowther) - shifted in on jumping away onto UP THE LANE.

UP THE LANE (R. Hurdle) - hampered on jumping away when tightened onto WETSHOT by TOTALLY DISCREET. Raced wide without cover throughout the event. Rider reported that the filly had only travelled fairly and when placed under pressure changed legs and in his opinion, felt uncomfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: IRISH SPRING FLING AT MORPHETTVILLE - SATURDAY NOVEMBER 6TH HANDICAP - 1000 Metres

BRYAN'S BABE (T. Voorham) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. Near the 700 metres was inconvenienced when contacted by STRATEGY.



RACE 2: IRISH SPRING FLING AT MORPHETTVILLE - SATURDAY NOVEMBER 6TH HANDICAP - 1000 Metres (Cont'd)

STRATEGY (J. Holder) - raced keenly in the middle stages of the event and was inclined to shift about. Near the 600 metres was inconvenienced when taken in onto DISTANT LOVER by SKARA BRAE. Shortly after was taken out onto DISTANT LOVER onto BRYAN'S BABE.

FALLOW (B. Price) - jumped away awkwardly.

DISTANT LOVER (K. Crowther) - near the 600 metres was inconvenienced when tightened onto the hindquarters of RODEO by STRATEGY. Shortly after was taken back out onto STRATEGY by RODEO. Held up from the entrance to the straight until inside the 300 metres and then near the 100 metres was obliged to alter course to the outside of RODEO, which rolled in slightly.

JUSTA JILLAROO (J. Opperman) - jumped away awkwardly.

FREE WILMA (K. Zechner) - slow to begin.

RODEO (C. Murray) - jumped away awkwardly. Near the 600 metres was contacted on the hindquarters by DISTANT LOVER and as a result, was turned back out onto that mare. Near the 100 metres rolled in slightly onto DISTANT LOVER.

SKARA BRAE (E. Finnegan) - shifted in near the 600 metres tightening STRATEGY onto DISTANT LOVER. Rider was severely reprimanded and advised to ensure she was sufficiently clear prior to commencing to shift ground in future.

RACE 3: FURPHY HANDICAP - 1300 Metres

MONA DREAM (G. Lo) - near the 100 metres brushed with DEEVINE when it attempted the same run as that gelding between STAR OF CHAOS and BUBBLES MCGINTY. Near the 50 metres had to steady momentarily and alter course to the inside of STAR OF CHAOS, which shifted out.

STAR OF CHAOS (B. Vorster) - raced keenly in the early and middle stages of the event. Inclined to lay out under pressure in the straight and near the 50 metres shifted out onto MONA DREAM. Rider was reminded of his obligations when shifting ground.

ARTFUL LIBBY (A. Jordsjo) - shifted out on jumping away onto MUFFLA.

MUFFLA (S. Metcalfe) - lost its position on jumping away when contacted by ARTFUL LIBBY.

A BIT RACEY (B. Price) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event.


DIVENIRE (P. Gatt) - rider reported the gelding felt uncomfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

BUBBLES MCGINTY (J. Holder) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn and under pressure in the straight.

WYNTER LADY (J. Potter) - near the 300 metres had to steady and alter course to the outside of DEEVINE, which shifted in.

DEEVINE (K. Zechner) - at the entrance to the straight was held up for a short distance and near the 300 metres, shifted in to obtain clear ground and in doing so, shifted in onto WYNTER LADY, which had to be steadied. Rider severely reprimanded and advised to ensure he was sufficiently clear when shifting ground in future. Near the 100 metres brushed with MONA DREAM when it attempted the same run as that mare between STAR OF CHAOS and BUBBLES MCGINTY.

RACE 4: MASTER BUILDERS SOUTH AUSTRALIA HANDICAP - 1550 Metres



WERTHEIMER (NZ) (C. Murray) - raced keenly in the early and middle stages of the event. Near the 300 metres had to be checked to avoid the heels of COMFORT GIRL, which shifted out and lost its position. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.



RACE 4: MASTER BUILDERS SOUTH AUSTRALIA HANDICAP - 1550 Metres (Cont'd)

BONIFACE (NZ) (B. Price) - raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

COMFORT GIRL (K. Crowther) - near the 300 metres shifted out when insufficiently clear of WERTHEIMER (NZ), which was forced to check to avoid the mare's heels. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 30 October and to conclude at midnight on Thursday, 4 November 2021: a period of three meetings.

IOWA HAWKEYE (D. Caboche) - raced keenly in the early and middle stages of the event.

RACE 5: THE JUNCTION HANDICAP - 1000 Metres

MAYAMEEN (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

TRIP (K. Crowther) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

ENCHANTINGLY (T. Pannell) - slow to begin. Rider reported that the mare slipped behind on jumping away, had never travelled and in his opinion, is better suited on softer tracks. A post-race veterinary examination revealed no visible abnormalities.

IDEAS MAN (B. Vorster) - raced keenly in the early and middle stages of the event.

RACE 6: MELBOURNE CUP DAY AT MORPHETTVILLE - TUESDAY NOVEMBER 2ND HANDICAP-1250 Metres

STREET TOUGH (T. Pannell) - slow to begin and shortly after was hampered and was contacted by MESSERSCHMITT.

TRITON RISING (C. Murray) - near the 200 metres raced in restricted room for a number of strides when awkwardly placed between CALL ME CURTIS and TULLYS GOLD and had difficulty obtaining clear ground until near the 100 metres.

ALL IMPORTANT (D. Tourneur) - laid out over the concluding 700 metres. A post-race veterinary examination revealed no visible abnormalities.

MAY BE FATE (B. Price) - held up from near the 400 metres until near the 200 metres.

CALL ME CURTIS (G. Lo) - laid in under pressure in the straight.

TULLYS GOLD (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

VIEIRA (E. Finnegan) - rider reported the gelding hung in throughout the event.


MESSERSCHMITT (S. Metcalfe) - jumped away awkwardly, shifted out and contacted STREET TOUGH.

RACE 7: WHITE CLAW HANDICAP - 2250 Metres

The start of this event was delayed approximately two minutes.

SLIPINTOTHIS (NZ) (T. Pannell) - lunged forward after being loaded, contacted and opened the front partition of the barriers. Underwent a pre-race veterinary examination at the barriers and passed fit to race.

SANTELMO FUEGO (C. Murray) - had to be momentarily steadied near the 500 metres when ALL HARD WOOD rolled in.



MARYMOUNT LASS (K. Zechner) - lunged forwards after being loaded and struck the front partition of the barrier. Underwent a pre-race veterinary examination which revealed the mare to be unfit to race. Declared a late scratching at 4.08 pm by order of Stewards on veterinary advice.



RACE 7: WHITE CLAW HANDICAP - 2250 Metres (Cont'd)

ALL HARD WOOD (J. Maund) - laid in under pressure over the concluding 600 metres and near the 500 metres rolled in onto SANTELMO FUEGO.

JACK'S A CRACKER (B. Price) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SKY HERO (K. Crowther) - laid out rounding the home turn.

RACE 8: GRAND SYNDICATES HANDICAP - 1400 Metres

RENEGADE (B. Price) - contacted on jumping away by TELL ME AGAIN unbalancing the rider. Raced keenly in the early and middle stages of the event and was wide without cover throughout the event. Laid out under pressure in the straight.

TELL ME AGAIN (T. Pannell) - shifted out on jumping away and made heavy contact with RENEGADE. A post-race veterinary examination revealed no visible abnormalities.

UNLACED (NZ) (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

SHE'S STYLISH (J. Holder) - slow to begin. Raced keenly in the early and middle stages of the event. Taken wider over the concluding 200 metres by RENEGADE.

BRED TO BOSS (T. Voorham) - a post-race veterinary examination revealed mare had bled from both nostrils. Co-Trainer, Mr A. Gluyas, was advised that as this was the mare's first bi-lateral bleed BRED TO BOSS would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

Correct weight was delayed to allow J. Holder (SHE'S STYLISH), placed third, to view the vision in the straight.

RACE 9: CANADIAN CLUB VIDDORA SERIES FINAL (QUALIFIED HORSES) - 1300 Metres

STAR OF UMA (B. Price) - raced wide without cover throughout the event. Rider reported that the gelding was caught wide from an outside barrier, never travelled and was under pressure from near the 800 metres. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Co-Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

LAKHANI ROSE (J. Opperman) - slow to begin.

ADORADANCER (E. Finnegan) - Trainer Mr K. Healy was questioned in relation to the instructions provided to his rider in this event. Mr Healy explained that the rider was advised to attempt to take up a forward position from its good barrier draw, which was similar instructions to when the mare had drawn well previously. He further added that it was not the intention for ADORADANCER to lead the race. Rider confirmed the instructions and added that it had not been her intention to lead however, the mare jumped away well and had found the lead of its own accord.

ANOTHER AWARD (J. Holder) - inconvenienced when taken wider rounding the home turn.

LADY DUNMORE (K Crowther) - inconvenienced when taken wider rounding the home. Laid in under pressure in the straight.

GLASS CEILING (B. Vorster) - raced wide without cover over the final 700 metres and hung out rounding the home turn inconveniencing LADY DUNMORE, ANOTHER AWARD and WURLIES LASTCHANCE, which were all taken wider. Rider reported that the mare hung out rounding the home turn and proved difficult to ride in the straight. He added that on pulling up the mare had made an excess respiratory noise. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.



RACE 9: CANADIAN CLUB VIDDORA SERIES FINAL (QUALIFIED HORSES) - 1300 Metres
(Cont'd)

WURLIES LASTCHANCE (D. Caboche) - inconvenienced when taken wider rounding the home turn.

ISSARA (J. Maund) - jumped away awkwardly and was slow into stride.
